Every attempt will be made to accommodate a larger number after the guaranteed number due date, if necessary. A list of specific lodging and a description of the units will be sent following this procedure.

Specific rooming assignment is the responsibility of the group representative, as agreed upon in the Chalet layout sheet. Specific chalet assignment is the responsibility of Brule Valley Management. A list of tenants will be given to Brule Valley Management at check in. Cancellation Policy: deposits are refundable less a \$50 handling fee, per chalet, if cancelled 30 days prior to arrival. Reservations cancelled within 30 days, no refunds. Initial \$100 deposit is non-refundable.

**Comp Package:** 1 Complimentary Package With 20 Paid (adult or junior) packages, 2 Complimentary Packages With 40 Paid (adult or junior) packages.

**Damages:** A pre-authorized \$500.00 damage deposit, in the form of a credit card (MasterCard /Visa), will be required per unit reserved. All units are checked prior to arrival. Any damages or items found missing following your departure will be charged directly to your deposit, according to Public Act No.56 .

Violation of the check out policy will result in a one night lodging charge for the same unit as occupied by the group. These charges may be deducted from the Security Deposit.

**Change Over Rooms:** Up to two change over rooms may be assigned to your group if requested.

Assignment of change over rooms will be made seven days in advance of check out. All items will be removed from groups lodging units and placed in change over units. Ski Brule and Brule Valley Management assume no responsibility for these items. If nobody is checking into a property on your day of departure, a late check out will automatically be extended to the group (5:00 PM).



**Tickets & Activity Passes:** The group representative will receive tickets and activity passes at check in time. These should be treated as cash and the group representative assumes responsibility for them. Lost tickets or activity passes will not be replaced. Unused tickets and passes are non-refundable.

**Additional Information:** A driver's license and MasterCard/Visa/Discover of the person renting the chalets is required at check- in. Renter must be 25 years of age. Guests of the Brule Saloon must be 21 years of age.
