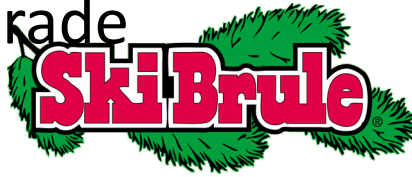

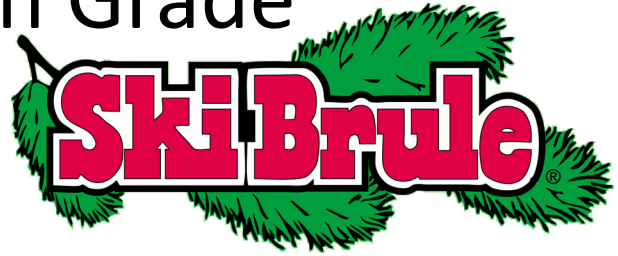

Rental Forms: Participants will need to complete a Ski Brule rental form every Friday and have signed (2 locations) by their guardian. Rental forms can be picked up at Ski Brule or at www.skibrule.com. You are welcome to complete a rental form for your child (except the date & signature) and make photo copies of the form. Then all you have to do is date & sign for each session.

Early Arrival: Participants are welcome to arrive at Ski Brule directly from school or arriving between 3:00 & 3:45. If you are an early arriver, please go to the cafeteria at the main lodge. A Ski Brule staff person will meet you there and organize activities until it is time to pick up rental equipment.

Arrival: The night session begins at 4:30 so we'd like the participants ready to ride by then. Participants should arrive no later than 4:00 at the Rental Center at Ski Brule.

Liability Release: Please complete the liability release for your participants. This only needs to be done one time and turned in at the first session of the program.

Proper Clothing Includes: winter jacket, snowpants, tall socks that almost reach knees (wool socks are preferred over cotton), mittens or gloves (not knit mittens or gloves), balaclava or neck warmer (no scarves), goggles & hat. If you don't have these items, they are available to purchase at reasonable prices (special Stambaugh Elementary Friday Ski Night participant pricing) at Bear's Den Pro Shop. Ski Brule is hoping to collect donated items for children to use that don't already have these items to utilize during the program.

Helmets Are MANDATORY & Included With Rental Equipment

Unconditional Liability Release Agreement & Indemnification Agreement (read very carefully)

I understand by my signature below or the use of premises and/or equipment that this document is a liability release and waiver by which I am giving up all of my rights of every kind (including rights of a minor for whom I sign) to claim damages against Ski Brule, Inc., Brule Valley Management, Inc., Benefit Lands, Inc., and any associated entities, lessors, officers, stockholders, and employees (Ski Brule).

By my signature and/or use of equipment and/or premises I agree, acknowledge and contract with Ski Brule, and all of its related entities and individuals as follows:

- Each person who participates in the sport of skiing accepts the dangers that inhere to the sport.
- I understand that there are inherent risks in the use of this equipment, that injuries are common and ordinary occurrences of the sport and I freely and voluntarily accept those risks.
- I understand that the binding system will NOT RELEASE at all times or under all circumstances where release may prevent injury or death. That it is not possible to predict every situation in which it will release and it is, therefore, no guarantee of my safety.
- I understand how to use the equipment – I will use it as it is designated to be used.
- I agree to inspect the equipment and accept it as is, only if it is satisfactory to me. I accept full responsibility for the care of the equipment and agree to pay Ski Brule for any damages or loss for non –return.
- I have made no misrepresentations concerning my height, weight, age or type. I agree to compare the binding setting with those posted for my height, weight, and ability. By use of the equipment, I agree that the settings are correct.

I hold Ski Brule completely harmless and not liable and release them from all liability whatsoever and hold them harmless from any and all claims, causes of action, injuries, damages, costs or expense of every kind including claims for a minor for whom I sign, arising out of the use of this equipment, facility and premises without limitation, including those based on death, bodily and/or injury, property damage. I accept this equipment and premises as is. I assume full responsibility for my injuries and damages regardless of cause. I agree to indemnify Ski Brule for all damages whatsoever arising from my use of these premises. I REPRESENT THAT I AM OF LEGAL AGE (18 IN MICHIGAN) OR THAT THE SIGNER IS LEGALLY RESPONSIBLE FOR A MINOR USING THE RENTAL EQUIPMENT.
